Dick Zelmer (W. Clear Lake Rd)- Resident stated that internet service is lacking in the township and he would like to have the Board explore the possibility of obtaining funding for broadband internet.

### CORRESPONDENCE-

Easement for Access- Email from Attorney

Discussion amongst Board members regarding the access for two residents that have been using the northside of the Township parcel for access to their properties for several years. Ferris has offered to purchase the 66 ft wide access lane that he currently uses as his driveway. Board members were in favor of this solution. Reitz stated that while she wanted to make sure that Ferris continued to have access, she also wanted to make sure that the other resident would still have the same access if the parcel of land was sold. She stated that without that it could cost the other resident thousands of dollars to put in a new driveway.

Motion by Huebner, second by Dehring, to sell Lynn Ferris the 66 ft wide access strip of land per quit claim deed on the north side of the Township parcel with easement rights being provided to King residence at a price to be determined. Roll call vote showed unanimous support with Ferris abstaining, motion carried (4-0-1).
