House on South Redbud Trail

Cole-Crocker shared document from the City of Buchanan's Commissioner meeting that stated this property is located in the Township of Buchanan and is unsightly. City residents have been calling the City to complain. The Township Building Inspector is sending notice to the homeowner and will be collecting quotes for the price of demolition.
